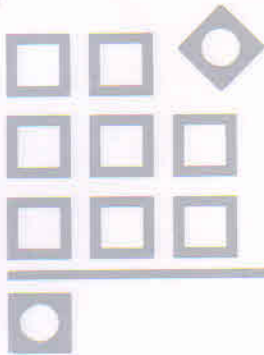

Minutes of the MRC meeting I/ 2020

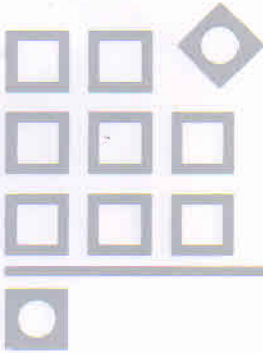
A meeting of ISO of Dr. Baliram Hiray College of Architecture was conducted on Wednesday, 7th September, 2020 in the conference room on the ground floor.
